- Any person who has a record of illegal drug use or a record of violent acts against persons or property
- Any person whose physical or mental condition is such as not to warrant confidence that the service to be rendered will not jeopardize the health, safety or welfare of any person
- Any person who fails to comply with all license or permit requirements
