

## TO ALL RESIDENTS AND PROPERTY OWNERS IN GARDEN CITY, CO

The Board of Trustees of the Town of Garden City has adopted Ordinance No. 04-2010 at a regular meeting of the Board of Trustees on March 16, 2010. The Ordinance re-enacted the Residential Landscape Improvement and Water Rebate Program for 2010 and future years provided a determination that the Board of Trustees may, by a majority vote, approve the program each year thereafter if funding has been appropriated in the budget.

The Water Rebate Program rebates half of your water bill from May through August, to a maximum of \$400. You will be required to submit copies of your water bills for those months to receive the rebate.

The Rebate application must be complete including all attachments and received by the Clerk's Office at the Town Hall 621 27<sup>th</sup> Street Road by the last business day in May. The Board will not accept late or incomplete applications. Please make sure you include a copy of the front page of your lease (if renting), a copy of two water bills paid in the previous 12 months, and a photo of your property before the season starts.

Please come to the Town Hall to get an application or you may download one at http://townofgardencity.com.

The deadline for the submission of photos at the end of August and the summer's water bills is September 15. The rebates will be awarded after September 15.

	3. The rebate is paid at the discretion of the Board of Trustees or a committee selected by the Board.  4. The rebate amount will be one-half of the totals of your water bills for the months of May, June,
	July and August up to a maximum rebate amount of \$400.
	Save your May, June, July and August water bills as you cannot receive the rebate without proof o

	5. Take photographs of your landscape at the end of August and submit them to the Town
	by the deadline of September 15.  6. Grant amounts will be approved or disapproved after September 15.
	7. Grant rebates will be based upon your contribution to the enhanced appearance of the neighborhood.
