Police Comprehensive Plan Committee Update

The committee agreed that the PD will utilize the Town's Facebook page until their volume increases enough to warrant their own page.

Update on 8th Avenue Realignment Project

a. Consider Additional Tree Species

Manuel Ramos moved, and Tara Murlowski seconded to approve the Brandywine Maple Tree as an additional species for 8th Avenue. The Board agreed that half of the trees will be Kentucky Coffee Trees and half Brandywine Maple. 6 Aye. 0 Nay. Motion carried.

b. Consider Stamped Concrete Pattern

The project is on schedule. J.C.York from J & T is working with Xcel to get the street lights relocated. They are pouring sidewalks on the north end and plan to start paving next week.

Attorney Amy Penfold reported that four of the six required easements for the 8th Avenue Realignment Project have been returned, we are waiting on the easements from the Garden City Flea Market and Rick's Furniture property owners.
