April 19, 2005

Mayor Miller called the meeting to order at 7:30 P.M. Board members present were Mayor Eddie Miller, Mary Miller, Terry Greenwood, Dennis Kendrick, Vince Loftus, Nina Kendrick, and Clarence Krieger. Staff present was Attorney Don Hoff and Town Clerk Janice Walter.

Minutes & Treasurer's Reports

Vince Loftus moved and Mary Miller seconded to approve both the Minutes of Regular Meeting March 22, 2005 and the Treasurer's Reports for March 2005. 7 aye. 0 nay. Motion carried.

Use By Special Review No. 01-2005 Order

Don Hoff presented an order approving Use Special Review No. 01-2005 for a used car lot to Greeley Area Habitat for Humanity and PBRJD Greeley Land Enterprises, LLC for the Boards consideration. Dennis Kendrick moved to approve the order and authorize the Mayor and the clerk to sign the order. Terry Greenwood seconded. 7 aye. 0 nay. Motion carried.

CML Announcements

The clerk announced that the CML Spring Outreach Meetings had been scheduled. There is a meeting in Fort Collins on May 23, 2005 from noon to 1:30 P.M. All elected officials are encouraged to attend.

Street Lights

The clerk reported that she had called Todd Anderson with our request but was still waiting to hear from Xcel Energy on changing the bulbs and bending the light fixtures toward the street. She also stated that she had reported all six of the street lights being out in the 2700 block of 8th Avenue on March 7th and several times since then.

Other Board Issues

Clarence Krieger asked the Board if we should consider getting our own police department. After considerable discussion, the Board asked the clerk to check into the cost of having our own department.

The Board had received a verbal report from Chief Guthrie prior to the meeting concerning disorderly conduct at the El Carousel and serving a minor at Jack's Place.

On the 11th of April at 1:36 a.m. officers responded to El Carousel on the report of disorderly conduct. During the investigation it was determined that a 15 year old girl was one of the participants. She had been at the bar all evening. While there was no report of her drinking, she had been a victim in disorderly conduct and was out past curfew. The fifteen year old and her father were issued a curfew violation citation.

On April 2nd officers responded to Jacks Place on the report of a man carrying a gun. Upon investigation an 18 year old man was found to have a loaded semi automatic gun that had been stolen and a baggie of cocaine. He stated that he had drunk two beers at Jacks. He stated he was carrying the gun because while at Jacks Place the previous week, someone had pointed a gun at him so he had the gun for protection. The 18 year old was issued a citation for carrying a concealed weapon and possession of cocaine. Brian Gough was issued a summons for selling alcohol to a minor.

Since there was no further business, Mayor Miller adjourned the meeting at 8:05 P.M.

The meeting was called back to order at 8:10 P.M.

There have been several complaints about the maintenance man. After considerable discussion, the Board decided that we should set up a meeting with Mr. Andolsek, Janice Walter, Mayor Miller, and Clarence Krieger to let him know what the Board expects from the assistant position. Clarence Krieger moved to set up the meeting and talk to Bob Andolsek. Terry Greenwood seconded. 7 aye. 0 nay. Motion carried.

Mayor Miller adjourned the meeting again at 8:16 P.M.
