The budget to actual for 2023 yearend will be distributed in February once all of the revenue for 2023 that is received in January and all expenditures paid in January but for 2023 are posted. Our 1st payroll with ADP went well, Cheryl will be staying tonight to be sure the next payroll for this Friday is submitted before noon tomorrow. The timeclock is active, and all hourly employees are utilizing the app.

b. Police Chief

The new Police pickup truck was parked outside for show and tell. The hybrids are different but will hopefully be better on the budget. The new Police Technician has been busy organizing the Police Department. There are two part time officer candidates that should be on board soon. The cold weather shelter is under new management, the Chief will meet with Greeley PD next week at the shelter. Officer Perez is still on leave.

c. Public Works Director

Brett attended the 34 Coalition meeting. There was not anything said pertaining to Garden City. Brett was in Saturday and Monday for snow maintenance. 2Bros will start construction in the Community Center on Monday January 22nd.

d. <u>Town Attorney</u>

No report.

Consider Property Purchase (May be an Executive Session)

Tammy Malick addressed the Board regarding the offer the Town made to purchase the vacant lot on 6th Avenue Ln. She presented a counteroffer in the amount of \$40,000.00. Leigh Sorensen moved, and Alex Lopez seconded to accept the counteroffer and enter into a contract to purchase the vacant lot for \$40,000.00. 6 Aye. 0 Nay. Motion carried.

Other Board Issues

The Board discussed the current protocol of closing Town Hall when the County closes its operations. The Board does not think the Town should continue that protocol and instead instructed the Administrator to determine when Town Hall will close or have a late start. The Board informed staff that they would rather see a late start of 10 AM than closing completely.
